On the occasion of 20th of June – Day of Croatian Forestry, **Croatian Forestry Society – Branch Office Bjelovar** is organising a jury exhibition

7th Bjelovar photography salon «Forest in Forester's Eye» with international collaboration

1. The exhibition will be held in Bjelovar *between June 10 and July 11, 2010*.
2. The photographs can be sent *until 1st May, 2010* to the following address:
HŠD Ogranak Bjelovar, Matošev trg 1, 43000 Bjelovar, CROATIA
3. The Exhibition jury will select the photographs for the exhibition.
4. The Exhibition jury will proclaim the Grand Prix of the Salon (with the possibility of independent exhibition within the following Salon) for 3 individual photographs and 3 best photography series.
5. The Exhibition jury will award up to three acknowledgments for individual photographs and up to three photographs for photography series.
6. All decisions of the Exhibition Jury are final and irrevocable.
7. Every author will receive a copy of the Exhibition Catalogue to the address in the application forms.

Competition rules:

- a) The motif should be within the prescribed topic: «Forest in Forester's Eye»;
- b) All members of the Croatian Forestry Society including both the active and retired staff, the employees of «Croatian Forests» («Hrvatske šume»), and the foresters from all countries of the world have the right of participation;
- c) Every author can apply to the Competition with up to 10 individual photographs and up to 2 series with 3-5 photographs; one series is considered one single photograph.
- d) The photographs should contain no applications; the longer sides should not be shorter than 24 cm, or longer than 30 cm. For the sake of anonymity, the backsides of the photographs should contain only the title and the order number of the application form; if you have your own digital record on a transferable media, please enclose it.
- e) Your own data and the photography data fill in the enclosed application form (please demand it from the organiser).
- f) The organiser has the right of organising the exhibition until the end of 2010 in other places of the Republic of Croatia;
- g) The organiser has the obligation of returning the received materials to the authors until March 2011;
- h) Every author is personally responsible for the presented motif; every author also permits the reproduction and publication of his/her photography in the publications of HŠD and other media and publications for the purpose of promoting the Salon, unless the authors explicitly forbid it.
